*ELECTRICITY BILL MUST HAVE A PAST DUE BALANCE IN ORDER TO QUALIFY FOR ASSISTANCE . APPLICANTS CAN QUALIFY UP TO A \$1,200.00 CREDIT TOWARDS THEIR LIGHT BILL

Items needed to process EACH application are as follows:

- Current/ Unexpired Driver's License, State Issued ID, OR Sheriff Department ID. **Address on your utility bill must match your address on your ID. If the address does not match, you must provide a water bill , cable bill, etc. as proof of residence**
 - Original Social Security Cards for **ALL HOUSEHOLD MEMBERS.**
 - Proof of Income for **ALL HOUSEHOLD MEMBERS** (Social Security, SSI Benefit, Retirement Payments or Pension, Food Stamp Printout ETC). **IMPORTANT: Income must be for the year 2022**
 - ----If you are currently working, we need the last 4 CONSECUTIVE check stubs from your employer, no exceptions. If you are not working, you will be required to sign a ZERO INCOME STATEMENT FORM and check off the appropriate reason(s) that you are not currently working.
 - Most recent/ current light bill (Light bill must have a Past due amount)
- **ALL ITEMS MUST BE PRESENT TO RECEIVE SERVICE; NO EXCEPTIONS or THE APPLICATION WILL NOT BE PROCESSED.**

After signing the release form, all applications will be taken back to the Community Action office for processing. Please allow 7-10 business days from the date that the application is processed to determine if you will receive assistance. We will mail out Client Qualification Notices or Denial Letters.
